Our environment is welcoming, friendly, non-judgemental and very encouraging. Many girls/ladies go on to gain enough confidence to join a regular netball club or even support others by volunteering their services to support new clubs. Some junior members go on to represent Cornwall in many competitions. At St Agnes we support those who find it difficult to purchase kit and/or require discretionary assistance with session fees or attending events further afield. We always try to keep funds aside to ensure no member is excluded from participation due to inability to pay. Having distinctive netball markings on the court helps to build confidence in younger members as well as the older members who may not have played the game previously and are unsure of the rules of play.
